

PRIVACY- AND COOKIE STATEMENT WAVIN

“We will keep your data safe and give you full transparency about your data and full control of your data”

This is the Privacy and Cookie Statement of the website www.wavin.com/fi_fi (hereinafter referred to as: 'Website'). This statement applies to all personal data that Wavin B.V. and Wavin-Labko Oy, Visiokatu 1, 33720 Tampere, (hereinafter referred to as 'we', 'our' or 'us'), processes of its website visitors (hereinafter referred to as: 'you' and 'your data') via the Website.

This statement will explain how we will use the data that we collect via the Website and which rights you have with respect to your personal data.

1. How we collect and store personal data

Personal data is any information that directly or indirectly identifies a natural person. Such information could include a name, e-mail address and the IP-address of your computer.

We process your data for the purposes set out below. For as far we collect personal data through cookies, please find more information under paragraph 2.

Wavin stores relevant information about website hits, visitors, contacts and customers into different systems, to be able to service our customers, potential customers in the best way we can. Some information is used to be able to contact you or to help segmenting or profiling. We will now explain what types of information we store and why we need this information.

A. MY WAVIN ACCOUNTS

In order to be able to login to my Wavin account, where you can obtain personalized services, such as personal ranges and/or price lists, Wavin stores your username (e-mail address), password, gender, surname, last name and company name. We are allowed to process this data on the basis of article 6(1)(f) of the General Data Protection Regulation, since it is necessary to secure the access to our Website.

You are required to provide personal data for this purpose. If you do not provide personal data for this purpose, we are not able to provide you with access to your account or provide information with respect to price lists.

B. CONTACT FORMS

In order to be able to answer questions or comments via contact forms, we can ask for your email address and optional your name and company name. We are allowed to process this data on the basis of article 6(1)(f) of the General Data Protection Regulation, since this information is necessary to answer your question. You are required to provide personal data for this purpose. If you do not provide personal data for this purpose, we might not be able to contact you and answer your question.

C. NEWSLETTER

In order to be able to send newsletters to Wavin newsletter recipients, we ask for your e-mail address and optional your name, initials and gender and additional information like company name or a functional classification to be able to send you the right content. If you receive our newsletters, we may use your online clicking behaviour to personalize our newsletter and Website for you. We are allowed to process this data based on your consent. You are at any time allowed to withdraw your consent. If you do not provide personal data for this purpose, we will not provide you with a newsletter.

D. ONLINE CAMPAIGNS

To motivate and stay connected to our customers and potential customers, Wavin launches campaigns frequently. Besides newsletter subscription information, we can ask for additional information like addresses, phone numbers or product usage, to provide more relevant content and messages to our visitors and users for price matching and other purposes. Further information is provided per campaign. We are allowed to process this data based on your consent. You are at any time allowed to withdraw your consent. If you do not provide personal data for this purpose, we will not provide you with relevant content and messages.

E. E-MAIL MARKETING

We may collect your e-mail address and optional your name, initials, gender and additional information like company name or a functional classification, in order to send you commercial e-mails. We are generally allowed to process this data based on your consent. You are at any time allowed to withdraw your consent. However, if you provided your contact details intentionally for the purpose of receiving commercial e-mails from us or if you are an existing customer (someone to whom a product or service is sold by Wavin and whose contact details are acquired in the context of this sale) and the e-mail concerns similar services or products, we are able to process your personal data without your consent and based on article 6(1)(f) of the General Data Protection Regulation, since this information is necessary in order to conduct our business activities. In this case you can object to the use of your personal data at any time we send you an e-mail.

F. SOCIAL MEDIA

Via social media we bring our content to our target audiences to be able to stay engaged with Wavin in the environments that our target audiences are most active on. We can store engagement moments and behaviour like replies on our content or sent messages to our social media inboxes. Information about social media behaviour can be connected to data about Website behaviour and based on such information we can personalize your experience on our Website. We are allowed to process this data based on your consent. You are at any time allowed to withdraw your consent. If you do not provide personal data for this purpose, we will not obtain your data and are not able to personalize your experience on our Website.

G. WAVIN ACADEMY

In order to register you for training by the Wavin Academy, we can ask for and process your name, company name, telephone number and e-mail address. We are allowed to process this data on the basis of article 6(b) of the General Data Protection Regulation, since it is necessary to conclude a contract with you. You are required to provide personal data for this purpose. If you do not provide personal data for this purpose, we are not able to train you.

H. COOKIES

Wavin uses “cookie” technology, and other similar technologies, to collect additional Website usage data and to improve our services.

What are cookies?

A cookie is a simple and small file that is stored on your device, for example to offer the basic functionality of the website, to remember your settings and preferences and for statistical purposes. Different types of cookies exist, depending on their features and functions, and they might be stored on the users' devices for different timeframes: session cookies are cancelled at the end of each browsing session; persistent cookies may last up to a certain date that has been pre-set by their owner. Besides cookies, there are other digital techniques to store information or to gain access to information stored on your terminal equipment. We will treat these techniques as if they were cookies and if we mention cookies in this privacy statement, we also refer to these techniques.

What is the difference between first party and third party cookies?

We differentiate first party cookies and third party cookies. The word "party" refers to the domain as specified in cookie: the website that is placing the cookie. First party cookies are managed by Wavin itself or used on behalf of Wavin and refer to Wavin's domain. Third party cookies are placed by third parties and refer to their domain name. For example: If we embed YouTube movies into our Website, also cookies from the YouTube domain will be placed.

What specific cookies does Wavin use?

We use the following kind of cookies on the Website, and will explain the purpose of these kind of cookies. Explanation of cookie types

Cookie type	First / third party	Explanation
Functional cookies	First party cookies	Wavin uses functional website cookies to help you login to your accounts if you have registered in for these accounts or for submitting forms.
		Wavin can also place cookies to help testing Website changes & improvements for a better user experience.
Analytical cookies	First and third party cookies	Analytical cookies allow us to recognise and count the number of visitors to our Website, to see how visitors behave on the Website and to record which content is read. This helps us to determine how frequently particular pages are visited and to determine the most popular areas of our Website and/or services. This helps us to improve the Website and the services offered to you.
Personalization cookies	First and third party cookies	Selected third parties can place behavioral tracking cookies to track personalized behavior on Wavin websites with the purpose to create and serve better and more personalized or segmented content. More information about the logic involved, as well as the significance and the envisaged consequences of such processing can be found here [Link to all cookies]

Please note that Wavin could be required under local law to obtain consent from you for the use of some of the cookie technologies. If so, we will ask you to consent with the placement of the cookies when you enter the Website. If you do not consent with the placement of the cookie, we will not place the cookie. However, in that case we are not able to personalize the content on our Website. If you have consented with the use of cookies, you have the right to withdraw your consent at any time.

When functional or analytical cookies are rejected, Wavin will not be aware of its Website performance and content quality and Wavin is not able to improve the user experience of the Website.

Please note that if you set your browser to disable cookies, the Website might not work properly and some services or some of the Website's functionalities may not be available or work smoothly, and you could be required to modify or manually fill in some information or preferences each time you visit the Website.

2. How we might share personal data

In general, we will not share your personal data with group entities located outside the European Economic Area ("EEA"). We may share your data with our group entities in the European Union. Cookies can be placed by third parties. Please review the list of cookies to see which parties collect such data.

We may share your data with third parties that provide database-, server-, maintenance-, security-, marketing- or other similar services to us (hereinafter referred to as 'data processors'). If we provide access to your data, we require the third parties to keep your data confidential and instruct these parties to process this data only on our behalf. Some of these third parties are established in countries outside the EEA. We concluded controller-to-processor EU Model Clauses with data processors outside the European Economic Area in order to ensure that your Employment Data is adequately protected. You may contact us by using the contact details at the bottom of this privacy statement, if you wish to review the relevant data transfer agreements.

Furthermore, we may also disclose your data if we believe that the disclosure is required by law, or is in response to a legal request.

3. How we secure your data

We implemented appropriate technical and organizational measures to protect your personal data against accidental or unlawful destruction or accidental loss, alteration, unauthorized disclosure or access and against all other forms of unlawful processing. Also, we require our data processors to implement such appropriate technical and organizational measures.

4. When we will remove your data (retention periods)

Your data will be stored no longer than is necessary for the purposes for which the personal data is collected unless otherwise required by law. For example, if you delete your account or opt-out from communications, we will delete the data, unless this data is required for another purpose set out in this policy or if we are required by law to retain the data.

With respect to the specific retention periods of cookies, please check the list of cookies under 1(H).

5. Your rights

You may contact us by using the contact details at the bottom of this privacy statement, if you wish:

- to know whether or not we process your personal data and access your data;
- to rectify your data;
- to erase your data;
- to restrict your data;
- to object against the processing of your data; and/or
- us to transmit your data to another organization.

We may request provision of additional information necessary to confirm your identity. We will provide information on the actions taken without undue delay and in any event within one month of receipt of the request. That period may be extended by two further months where necessary, taking into account the complexity and number of the requests. We shall inform you of any such extension within one month of receipt of your request, together with the reasons for the delay.

You have the right to lodge a complaint with a supervisory at any time.
